## **BAKTAT Germany Token**

BAKTAT Germany Tokens are not in any way to be construed as an asset token or linked in any way to asset tokenization arrangements, nor does ownership of BAKTAT Germany Tokens automatically provide holders access to asset token sales. The BAKTAT Germany Tokens is a strict utility token that allows land shareholders to access features on the BAKTAT Farm Platform and are in no way linked to asset token arrangements, asset tokens, or tokenized real estate. For the avoidance of doubt, the products and services of the platform that BAKTAT Germany Token can access and avail themselves to are products and services not linked or associated in any way with the process of Asset Tokenization or Tokenized Asset DeFi, house-flipping etc. as described in this BAKTAT Germany Token.

## **Platform Fees**

The BAKTAT Germany Token is used as a fee mechanism for platform features. The Asset BAKTAT Germany Token incurs borrowing interest which must be paid in BAKTAT Germany Token. The Auto-Compounding feature converts rental BAKTAT Germany Tokens in order to fund additional Asset Tokens for the investor. BAKTAT Germany Token marketplace transactions and sales also incur fees on up to 2% of the transaction amount.

## **Future Support and Features**

All additional features to the BAKTAT Farm platform will require the BAKTAT Germany Token to grant access, use as a payment method, or be required for collateral.

We are a Data Controller of your information.

BAKTAT Germany Tokens legal basis for collecting and using the personal information described in this Privacy Policy depends on the Personal Information we collect and the specific context in which we collect the information:

### **Log Files**

BAKTAT Germany follows a standard procedure of using log files. These files log visitors when they visit websites. All hosting companies do this as a part of hosting services' analytics.
